#### Item 5: Incident Review

Cementation - Charlie Toeppner reviewed an incident where a loaded haul truck backed into a parked haul truck

Dumas - Ken Leavoy reviewed an incident where a haul truck went partially off the side of a surface weigh scale

Technica - Jake Hughes presented an incident where a forklift tipped over with a raised shotcrete bag

## Item 6: Ministry of Labour Orders Appeals Process

The group reviewed new forms which are now in place to appeal orders issued by the Ministry of Labour.

#### Item 7: Innovation Contest

Cementation – Steve Wrixon presented an innovation where employees designed an adjustable jig for drilling holes in a shaft for slickline brackets

Dumas – Members from the Dumas maintenance facility presented a safe way to install aircraft cable through a bull hose for a raise setup

#### Item 9: Committee Reports:

1. Legislative Review Committee Update - Dennis Sobey from Derek Budge

- Meeting held March 7-8 in Sudbury
- Industry side of MLRC requested further discussion with MAESD the MTC co-chairs and the MOL regarding Industry concerns over the MTC proposed supervisory CC recommendations. The request was agreed to by all meeting to be held in April
- MLRC Ad-Hoc sub-committee working on proposed regulation requiring mine operators to establish a written MOC procedure. This will satisfy MHSP review rec 1.5
- MLRC agreed that the Vent and Hygiene sub-committee will develop a priority scope of work regarding air quality vs air volume. This is separate from existing diesel regulation 183. Scope of work to include evaluating current DPM requirements and consider lowering them.
- MLRC approved proposed regulation requiring an employer to develop and maintain a written airborne hazard management program will now go through MOL regulatory process



- Currently 9 regulation guidelines posted to the MOL website they are
  - Brakes for vehicles
  - High Vis apparel
  - Non routine hazardous tasks
  - DPM sampling
  - Testing undiluted exhaust
  - UG Refuge Stations
  - Wheel Chocks
  - Rims and tire assemblies
    Post blast examinations
  - Conveyor guarding
- Two 2 day Risk Assessments were conducted with the MOL and the Ground Control Sub-committee
- October 18-19 and December 6-7. Awaiting the report to be published.
- One 2 day Risk Assessment was conducted on mobile equipment with the MOL and the Traffic Management sub-committee. Awaiting the report.
- Hoisting sub-committee is still working on regulation and guideline for IPC's
- There was a presentation by Horne Conveyance on new technology available for an alternative safety mechanism to "Dogs" for shaft cages
- 2. Mine Rescue Update Wayne Carey
  - Last meeting held on January 23<sup>rd</sup>
  - Some openings still within Ontario Mine Rescue
  - Onaping station is looking for an alternative location
  - Timmins station also in the process of relocating
  - Handbook revision is still in process
  - Briefing Officer training module has been piloted
  - Relief Mine Rescue Officer training module in process
  - Tablet program is on-going with more testing taking place
  - Seeking advice from Ground Control TAC on use of temporary anchors
  - Major revision taking place to First Aid procedure
  - District and provincial competition dates are set. Provincials at Young Davidson Mine and banquet in Kirkland Lake in June
  - International competition to be held in Russia
  - Total of 14 incidents in 2017 where mine rescue was involved
- **3.** MTC Update Charlie Toeppner
  - Trial session of the supervisory exam were written in Sudbury with 5 participants
  - Some questions were changed based on unclear wording or multiple answers
  - Meeting with MLRC regarding if exam needs to be legislated
- 4. Work Environment Committee Chris Betsill
  - No update
- 5. WSN Advisory Board Dennis Sobey
  - No significant advances
- 6. Equipment TAC Jake Hughes
  - Jake is the new OMCSA rep on this committee

- Update was provided on MOL Risk Assessment on Ground Control
- Updates on MOL sponsored research projects
